Textual Information()

Monsoon Studio Private Limited transferred 100 shares, representing 0.00% of share capital on June 1, 2021 to Naresh Malhotra by way of off market inter se transfer of shares between promoter and promoter group.

An encumbrance was created over the shares of the Company, by members of the promoter and promoter group, in favour of Nama Capital Limited (formerly known as Novator Capital Limited) (Nama) including on December 22, 2020, December 28, 2020, December 29, 2020, March 16, 2021, March 19, 2021, March 22, 2021 and April 26, 2023. On September 20, 2023, a release of encumbrance of these shares was made pursuant to settlement of the loan.

*A2R Holdings, Luxembourg, acquired 35,26,350 equity shares having face value of Re. 1 each of the Company (aggregating to 1.18%), on April 25, 2023, from Mr. Naresh Malhotra, pursuant to an inter-se transfer of shares amongst promoter and promoter group.

1,49,00,000 shares held by Mr. Namit Malhotra were acquired by him when he was a Resident of India.

*A2R Holdings, Luxembourg, re-domiciled from Mauritius to Luxembourg with effect from July 20, 2023 therefore nationality of A2R Holdings, has been changed accordingly under SBO tab.

The ESOP Compensation Committee of the Board of Directors of the Company at its meeting held on May 30, 2024 allotted 23,000 fully paid-up Equity Shares of Re. 1/- each respectively pursuant to the exercise of Stock Options under PFL ESOP Scheme 2014. The said shares rank pari passu with the existing Equity Shares in all respects. Consequent to above allotment, the Paid-Up Share Capital of the Company will increase from Rs. 29,98,48,644/- (i.e. 29,98,48,644 Fully Paid-Up Equity Shares of Re. 1/-each) to Rs. 29,98,71,644/- (i.e. 29,98,71,644 Fully Paid-Up Equity Shares of Re 1/- each).
